Councilmember Simechak made a motion to approve the Second Reading of Application 160-Special Events Retail – more than 30 days. Owners: Ben Brown, 1301 Haisten Dr., Dothan, AL 36301; Kevin Smith, 419 Drake Dr., Dothan, AL 36305., which motion was seconded by Councilmember Perault. The Council voted unanimously in favor thereof.

Councilmember Enfinger made a motion to authorize the Mayor to execute a Lease Agreement with M1 Support Services at Eastgate Business Park for Suite 103 at \$350 per month and Suite 105 for \$200 per month, which motion was seconded by Councilmember Simechak.
