The City Council of the City of Ozark, Alabama, met in Regular Session in the Council Chamber of the Municipal Complex at 6:00 P.M. on Tuesday, December 1, 2015. Upon roll call the following members were present:

Councilmember Garrett gave the prayer followed by Mayor Blackwell leading everyone in the Pledge of Allegiance.

The Council having read the minutes from the Regular Council Meeting held on November 17, 2015, President Gilland asked the wishes of the Council. Councilmember Garrett made a motion to approve the minutes of the Regular Council Meeting held on November 17, 2015, which motion was seconded by Councilmember Jackson. The Council voted unanimously in favor thereof.

President Gilland advised the Council it was time to set the Agenda and if there were any changes to be made. Councilmember Jackson made a motion to add to the Agenda the item presented by the Mayor during the Administrative Meeting to authorized the mayor to release the First Mortgage requested by DynaLantic Corporation and to add the Ordinance previously presented that contained an increase in the local fuel tax of 4 cents, which motion was seconded by Councilmember Garrett. The Council voted unanimously in favor thereof.

Councilmember Barefield introduced an Ordinance to rezone property located on Dixie Drive from R-1 to B-4 and moved to adopt said Ordinance, which motion was seconded by Councilmember Hill. The Council voted unanimously in favor thereof.

Councilmember Jackson made a motion to authorize the Mayor to release the First Mortgage requested by DynaLantic Corporation, which motion was seconded by Councilmember Hill. Councilmember Garrett abstained from voting. The motion carried with 4 votes.

Councilmember Jackson introduced an Ordinance amending sections 11-130, 11-131 and 11-135 Chapter II, Article II, Vehicle Fuel Tax of the Code of Ordinances City of Ozark and moved for its adoption, which motion was seconded by Councilmember Garrett. The vote was recorded to wit: Ayes: Councilmembers Garrett, Barefield, Jackson and Hill. Nays: Councilmember Gilland. Ordinance carried.

President Gilland advised the Council that there was a copy of the Court Report in their packets for their review.

With there being no further business to come before this Regular Council Meeting of December 1, 2015, Councilmember Garrett made a motion to adjourn the meeting, which motion was seconded by Councilmember Jackson. The Council voted unanimously in favor thereof.
